

# Villa Park High School GRAD NIGHT 2023

## Waiver and Release of Liability

We request that \_\_\_\_\_ be permitted to participate in the all-night alcohol-free graduation event planned for the graduating seniors of Villa Park High School on Friday, June 9, 2023. We understand that students and/or their parents/guardians are responsible for transportation to and from Villa Park High School and assume any and all risks, liability and responsibility related thereto. Check-In is open from 7:30am – 9:00am and a current VPHS Student Senior ID is required. No one will be admitted into the event after 9:00am. Students will not be permitted to leave the event until the buses return to campus at 3:30am, June 10, 2023. At such time students will leave on their own accord and a check-out policy will not be in place. Any student who must leave the event before its conclusion must be checked out by a parent and will not be permitted back into the event/venue after they have been checked out.

We, the undersigned, acknowledge that participation in Grad Night 2023 is voluntary and we are voluntarily entering into this waiver and release with knowledge of the potential danger involved. The undersigned Parent/Guardian is allowing student participation in these activities with the knowledge that, as with any activity, physical injury is a possibility and hereby agrees to accept any and all risk of injury. We hereby agree that this event is organized by volunteers and that we release any and all organizers and volunteers of this event from any and all claims that may arise out of student participation.

We also agree that we will not make a claim against, sue, or attach the property of the Grad Night Committee, Orange Unified School District, or any volunteer/member thereof. We also understand the event will observe a zero-tolerance policy and that each student/ participant may be searched for illegal and inappropriate items.

We have carefully read this agreement and fully understand its contents. We are aware that this is a Waiver and Release of Liability and a contract between us, the Villa Park High School Grad Night Committee, and the Orange Unified School District. All students will follow the Orange Unified School District's Code of Conduct that is enforced during school activities.
